### Robert's Rules: Managing Your Motions (without becoming emotional)

#### 6 Steps to Handling a Motion

- 1 Member stands, recognized by presiding officer (PO) and makes motion
- 2 Another member seconds
- O 3 PO restates the motion to the assembly
- 4 Members debate (Is there discussion?)
- O 5 PO asks for the affirmative votes, then negative votes
- 6 Announce results of voting, instruct corresponding officer to take action, introduce next item of business

## OOPS!!!!!!

You have the right to rescind

✓ EXCEPT

- Motion to Reconsider must resolve before any other action is taken
- Ø Motion already executed if execution occurred in an irreversible manner, you cannot rescind but you can amend reversible portions
- Ocontract results and the other party informed

To Rescind – takes 2/3 voted UNLESS membership received prior notice
