WHAT IS H.I.M.S?

- ■What does H.I.M.S stand for?
 - ☐ Human Intervention Motivational Studies
 - ☐ Purposefully vague and ambiguous
- ■Who can enter into H.I.M.S?
 - ☐ Available to all Pilots, GA to Part 121
- ☐ How does one enter into H.I.M.S?
 - □ It is a *voluntary* program?

WHAT IS H.I.M.S?

- ☐ H.I.M.S is a MONITORING and SUPPORT Program
 - □ 14 CFR 67.107 (4), 14 CFR 67.401-defines Substance Dependence
- ■Substance Abuse is equally as disqualifying as any other disqualifying medical condition
- Must have a diagnosis to enter H.I.M.S
 - ☐ An extra set of stipulations to be met, much like any other disqualifying medical condition
- Career abstinence, no return to drinking

H.I.M.S--The Process

- Event-(DUI, DOT fail (random/for cause), or self-report).
 - ☐ What constitutes a DOT fail? Positive DOT test for drug or alcohol (BAC 0.04%)
- Evaluation
- ☐ Treatment (28 day min)
- □ Recovery Program (AA/NA)
- Aftercare
- ☐ No Notice Alcohol/Drug Testing
- □ P&P
- ☐ Special Issuance Monitoring Period (used to be 3-5yrs it is now lifetime)

FACT CHECK:

- □ I was arrested for a DUI, if I enter into H.I.M.S can I get my charges dismissed?
 - ■What do I need to do?
- What about the FAA? Do they need to know?
 - ☐ Securities Division-60 day notification
 - ☐ Medical Division-Form 8500
- □ I failed a DOT random drug or alcohol test. Can H.I.M.S save my job?

- □ It's only 1 FAA. Why do I need separate notices?□ 60-day notification letter□ What is it?
 - ☐ When do you need to fill it out?
- ■What are the consequences if I don't fill out the notices?
 - □ Nasty gram
 - **□** Suspension
- ■How will the FAA ever find out?
 - ☐ National Drivers Registry

The FAA-Securities

- ☐ FAA Security DUI reporting requirements
- ☐ Title 14 of the Code of Federal Regulations (CFR), Part 61.15 (e)
 - □ Pilots who have had an alcohol related Motor Vehicle Action (MVA) are required to report the information concerning their convictions and administrative action in writing to:
 - ☐ FAA/AMC-700 * within **60 days** of the MVA.
