#### **GENERAL INFORMATION**



#### **BACKGROUND**

The State Bar of Texas, an administrative agency of the state's judicial branch, is charged with many responsibilities, including providing educational programs for the legal profession and the public, administering the Minimum Continuing Legal Education program for attorneys, and managing the grievance process. A public corporation whose funding sources include lawyers' dues and continuing legal education program fees, the State Bar of Texas receives no appropriations from the State's General Revenue Fund. The State Bar is subject to sunset review by the Legislature and successfully underwent that process for the fourth time in 2017.

The State Bar of Texas had its beginning in 1882 when 300 lawyers and judges gathered in Galveston to form the Texas Bar Association. Desiring to establish a better vehicle through which attorneys would maintain the highest ethical standards, a bar committee began in 1927 to draft a bill that would unify the bar through legislation allowing further controls over standards of legal practice. The State Bar Act, which was adopted by the Legislature in 1939, mandated that all attorneys licensed to practice law in Texas be members of the State Bar.

#### **ORGANIZATION**

The State Bar of Texas is governed by a board of directors with 46 voting members who volunteer their time and expertise without compensation. The voting members include: three officers elected statewide by State Bar members (president, president-elect, and immediate past president); 30 attorneys elected from 17 geographical districts; six public (nonattorney) members appointed by the Supreme Court; four at-large directors appointed by the State Bar president; and three officers elected statewide by Texas Young Lawyers Association members (president, president-elect, and immediate past president). The State Bar includes committees, boards, sections, and divisions that are run by more than 4,500 volunteers, both lawyers and non-lawyers. Their responsibilities include general oversight of the bar, providing assistance to local bar associations, developing continuing legal education programs for attorneys, conducting educational activities for the public, and administering the grievance system. The staff at the bar's headquarters in Austin and in regional grievance offices in Dallas, Houston, and San Antonio support the work of the volunteers.

#### **TEXAS LAW CENTER**

Located in the Capitol Complex at 15th and Colorado streets in Austin, the Texas Law Center is the State Bar's headquarters. It is near the Supreme Court Building and State Capitol. The Law Center also houses the Governor Bill and Vara Daniel Center for Legal History, which features changing displays of legal history.



#### **BOARD OF DISCIPLINARY APPEALS**

Budget Code: 1295

**Purpose:** The Board of Disciplinary Appeals, appointed by the Supreme Court of Texas, is a tribunal consisting of 12 volunteer attorneys. BODA shall have and exercise all the powers of either a trial court or appellate court, as the case may be, in hearing and determining disciplinary proceedings. In re State Bar of Texas, 113 S.W.3d 730 (Tex. 2003). The Texas Rules of Disciplinary Procedure Part VII grant the board jurisdiction to hear: (1) appeals from decisions of the Chief Disciplinary Counsel whether a statement constitutes an inquiry or a complaint; (2) appeals by any party from an evidentiary panel judgment dismissing or imposing sanctions against an attorney; (3) requests to transfer any pending disciplinary proceeding when a committee fails or refuses to hear the matter or as fairness requires; (4) petitions to revoke the probation of an attorney who has been suspended by a grievance committee with at least a portion of the suspension conditionally probated; (5) compulsory actions based upon an attorney having been convicted of or having accepted deferred adjudication for an intentional crime; and (6) reciprocal actions based upon an attorney licensed both in Texas and in another jurisdiction having been disciplined in another jurisdiction. The board also appoints district disability committees to determine whether an attorney is suffering from a disability as defined in the Texas Rules of Disciplinary Procedure, issues disability judgments, and hears petitions for reinstatement following an indefinite disability suspension. ### STATE BAR OF TEXAS ATTORNEY GRIEVANCE PROCESS AND DISCIPLINE/DISABILITY SYSTEM

#### COMPLAINTS AGAINST ATTORNEYS (800) 932-1900

The State Bar Chief Disciplinary Counsel works with the local grievance committees and the Texas Commission for Lawyer Discipline to administer the attorney grievance process and discipline and disability system. A written grievance accusing an attorney of professional misconduct is initially reviewed by the Office of the Chief Disciplinary Counsel. If it is determined that the grievance alleges professional misconduct, as defined by the Texas Disciplinary Rules of Professional Conduct, the grievance is classified as a complaint and an investigation is initiated.

Each State Bar district has one or more grievance committees. The members of each committee are nominated by the local State Bar Board

of Directors members. Approximately 349 volunteer attorneys and public members serve on the 17 grievance committees across the state.

The Commission recommends to the Board of Directors an annual budget for the operation of the attorney discipline system.

## LAWYER REFERRAL SERVICES (FULL FEE AND REDUCED FEE)

Lawyer referral services enroll licensed attorneys who pay the necessary registration fee and meet basic guidelines. Callers referred to a participating attorney by a lawyer referral service receive a half-hour consultation for no more than \$20. After the initial half-hour consultation, should the caller decide to authorize the lawyer to take action on their legal issue, the caller and lawyer may negotiate fees. These fees may be on a full or reduced fee basis, depending on the program the attorney is participating in.
