ART. 39.14: DISCOVERY

- (a) Subject to the restrictions provided by Section 264.408, Family Code, and Article 39.15 of this code, as soon as practicable are receiving a timely request from the defendant the state shall produce and permit the inspection and the electronic duplication, copying, and phot graphing, by or on behalf of the defendant, of an offense reports, any designated documents, papers, written or recorded statements of the defendant or a witness, including witness statements of law enforcement officers but not including the work product of counsel for the state in the case and their investigators and their notes or report, or any designated books, accounts, letters, photographs, or objects or other tangible things not otherwise privileged that constitute or contain evidence material to any matter involved in the action and that are in the possession, custody, or control of the state or any person under contract with the state. The state may provide to the defendant electronic duplicates of any documents or other information described by this article. The rights granted to the defendant under this article do not extend to written communications between the state and an agent, representative, or employee of the state. This article does not authorize the removal of the documents, items, or information from the possession of the state, and any inspection shall be in the presence of a representative of the state.
- (b) On a party's request made not later than the 30th day before the date that jury selection in the trial is scheduled to begin or, in a trial without a jury,

- Case had gone from ND CA to Ninth Circuit to SCOTUS back down
- In November ND CA upheld LI's breach of contract claim



 Books, and Stocks"








Windows 11 2022 - How to Update






