² There is also a benefit to the “be kind, rewind” policy when designating a record. When designating a motion entered on the docket it helps (everybody) if the include the response is designated as well, even though filed by another party. This makes referencing the record easier when briefing because the district clerk supplements the record for cross designations and assigns a new volume number to the cross-designated items. If docket entries that will obviously be designated are not included in the original record designations, there may be multiple volumes of the record when it's quite likely there's only need for one volume. ROA ____ (Volume #) p. ____ is the common record citation format. If there's only one Volume #, then the need to search through multiple district court docket entries to find the correct volume is alleviated.

³ The length of time required to assemble the record depends on several factors. If there is a cross appeal or an unfilled transcript order the bankruptcy clerk may have to supplement the record and assign a new volume number to the supplement.
